



## Q3 Is your land or the land you manage in the eradication zone (Class A zone) or control zone (Class B zone)?






### Q4 What type of land do you manage, work on, have an interest in, or wish to comment on?





I wrote to the NT Minister and to TIO in 2020 shortly after we suffered from an extremely hot gamba grass fire and expressed these very same sentiments. Nothing has happened. Why? 2. The best way of controlling bad habits which pose a risk to life, limb and property is to educate and prosecute (ask the police). Get tough with those who repeatedly choose to ignore their legal and social responsibilities by failing to take action on extensive stands of gamba or fail to have or maintain fire breaks . Let's see a closer link being made between fuel load and weed control through public education adverts on the ABC and commercial stations. ABC show risk prevention measures in cyclone preparation; why are we not seeing public announcements in the NT on fire risk in the lead up to the Dry on the ABC? Have the NT Government taken any initiative on this? I've tried to find out from the ABC how that might happen in 2020 but its bureaucracy got in the way of my getting any meaningful response.


# Q12 Are you working towards becoming gamba grass free on your (less than 3Ha) block by July 2023?

# Gamba Grass Roots' Response to the

# 2023 Gamba Grass Weed Management Plan Survey

Gamba Grass Roots is a partnership between The Pew Charitable Trusts and Environment Centre NT. We raise public awareness of the threats posed by gamba to our homes, communities, tourism sector, and our unique Top End wildlife and landscape. We also highlight what needs to be done to reduce the gamba threat, call for increased action to provide more resources and funding to fight gamba, and support community involvement in creating solutions to the NT's gamba challenge.

We acknowledge the NT Government's commitments to reducing gamba grass thus far, and wish to highlight the community's strong calls for increased efforts, strategic focus and resources to keep them safe from gamba fuelled fires and protect our iconic Top End landscapes. We also wish to highlight the recent commitments by the Federal Government for increased gamba action, we recommend this gamba plan review develops a framework for integrating outcomes from this large investment in gamba control into its considerations.

#### Gamba Grass Roots' main recommendations in response to this survey are:

- 1. Increase Gamba Action Program Funding to \$300,000 per year for 4 years
- 2. Commit to an annual budgeted baseline of \$1 million per year for the Gamba Army for 4 years
- 3. Funding an increase of at least \$10 million over 10 years in response to Litchfield National Park Gamba Mapping Report

#### Our response to the 2023 Gamba Grass Survey questions are as follows:

- Q3. Gamba Grass Roots has an interest in gamba reduction and eradication across both the Class A eradication zone and Class B management and reduction zone. Gamba Grass Roots supporters come from a variety of backgrounds, local landholders, Aboriginal land managers, weed contractors, firefighters, scientists, tourism operators and community members who care about this threat to our Top End ecosystems.
- Q4. Gamba Grass Roots has an interest in and wishes to comment on gamba management on all rural and residential blocks, road verges, Government land, Commercial land, Pastoral land, Aboriginal lands, National Parks and Reserves, and others, including utility corridors, mining areas, defence land, etc. Basically, anywhere where gamba may be found.
- Q5. The main factors that motivate our community to deal with gamba grass issues and support gamba action are looking after nature, the safety of people and protection of built infrastructure, lifestyle, financial impacts of not taking action. We also provide advice, guidance and often act as a conduit between residents and Government agencies, make asks of political decision-makers to back action and ensure accountability for government's gamba efforts.

Q6. Gamba Grass Roots have participated in the 2020 consultation to develop the Weed Management Plan Gamba Grass 2020-2030, and the 2021 and 2022 'Have Your Say' surveys.

#### Knowledge of the gamba grass legal requirements

Q7. Gamba Grass Roots is very aware of the legal requirements to control or eradicate gamba grass, but we have concerns that the general public are still largely unaware. Putting materials 'out' is not the same as spending time to listen and engage with questions that the public may have about requirements. We would like to point out that those responding to this survey are likely to have a keen interest in the issue and already be engaged in gamba-related activities, so the response to this survey question is not likely to be indicative of the general population's knowledge.

Q8. Gamba Grass Roots finds out about gamba grass' legal requirements by reading the Weed Management Plan Gamba Grass 2020-2030, Gamba Fire Mitigation: Compliance Policy, and the Weeds Management Act 2001. We also seek advice from experts and discuss requirements with public servants and other interested parties. Many people we speak with at market stalls rely on us and the Weeds Management Branch materials that we distribute, for their information. We don't believe that it would occur to some people that gamba laws exist (other than it's a weed that they should get rid of) or that they would know where to look to find them. Putting gamba information in council rates notices was a great way to reach property owners, but not those renting. Real estate agents could be encouraged to distribute gamba grass information to their renters to ensure they are aware of their legal requirements. We have been asked at our stalls if the removal of gamba is the responsibility of the owner or the renter and are unsure of the answer, so refer renters back to their real estate agents. We know the public would benefit from further direct engagement opportunities with Weeds Branch, Bushfires NT and other relevant agencies.

Q9. We would like to see people educated about their gamba grass legal requirements via the media, radio and television advertisements, through real estate agents selling or leasing properties, and Weed Management Branch stalls at shopping centres and markets (which could also provide information about Siam Weed, Mission Grass, etc); and continuing to put flyers in rates notices, providing information when utilising the Gamba Action Program, and by the Weed Management Branch officers when neighbours report problem properties. Furthermore, to ensure consistency in public and internal communication and delivery it's important that Government Departments such as Department of Infrastructure, Planning and Logistics (DIPL) and their contractors are educated about the legal requirements, such as 15m gamba free buffers along both roadsides and their side of property fence lines, and on Crown land boundaries and tracks.

# Blocks less than 3Ha in the Class B control zone

Q10. Gamba Grass Roots don't physically manage gamba grass but we assist people managing gamba on a (less than 3Ha) block by providing information. We also regularly hear from community members on successes and challenges tackling gamba on their block and how things are progressing in their area with their neighbours.

Q11. We understand that small properties in the Class B zone are required to be gamba free as this is an achievable goal if all small blocks are supported and assisted to be gamba free, due to the reduced likelihood of reinfestation if all properties become gamba free and the scale of the

management area (less than 3Ha). No property, regardless of size, can remain gamba free though if the road verges, easements, and neighbouring crown land or larger properties have unmanaged gamba reinfesting the smaller blocks.

Q17. The community tells us at market stalls that they would be more successful with their gamba management if they didn't repeatedly get reinfested by neighbouring land parcels. People speak with us about problem neighbouring blocks, with road verges, easements, Power and Water pipelines, vacant lots, crown land, etc, being the most commonly cited sources of gamba reinfestation.

#### **Gamba Grass Assistance**

Q18. Gamba Grass Roots doesn't physically manage gamba, so we don't utilise the Gamba Action Program, but we promote it through our newsletters, social media, and market stalls where we speak with land managers who rely on the herbicide and equipment the program provides. We often get asked about this program directly and get mistaken for a Government agency/distribution point, due to our public outreach efforts.

Q20. The Gamba Action Program is crucial to assisting land managers reduce and work towards eradicating their gamba loads, meet their legal obligations, and keep communities safe from gamba-fuelled fires. It is also integral to the Northern Territory Implementation Plan for the National Partnership on Disaster Risk Reduction, plus is crucial to achieving the goals of the Weed Management Plan Gamba Grass 2020-2030. Particularly Goal 2 - Contain and control gamba grass by actively managing infestations across the Class B zone and preventing spread into new areas; and Goal 4 - Increase community capacity and willingness to participate in gamba grass management.

This 2022/23 year we had many people tell us that they were unable to get herbicide due to the program running out early, while others told us the amount of herbicide received was not sufficient to meet legal obligations, as a lack of adequate program funding resulted in less herbicide being available. Due to the cost of living and the cost of herbicide, many of these people are unable to purchase sufficient herbicide themselves and will struggle to manage their gamba, increasing the risk of dry season gamba-fuelled fires. There were a few people at the Freds Pass Market, who told us that they only had minor gamba infestations and were satisfied with the program, but they were definitely in the minority.

The Gamba Action Program requires an urgent funding increase if it is to ensure that Territorians can get access to enough herbicide to deal with gamba grass on their block to keep their homes and families safe, and for the program to meet the needs and expectations of the community.

Q22. Changes to the Gamba Action Program are absolutely needed to make the program more effective and to better meet the needs of the community. The program's funding has not increased since the program started in 2010. \$100,000 was sufficient for the program to meet community needs 13 years ago but is woefully inadequate in 2023. This insufficient funding resulted in the program not being able to purchase the necessary amount of herbicide required, herbicide running out in February when it was most needed, leaving many land managers unable to access any herbicide, and the herbicide quantities distributed not sufficient to meet the basic legal requirements of many properties. The Gamba Action Program Funding needs to be increased to at least \$300,000 per year for 4 years to meet the community's needs.

# Review of gamba plan

Q23. The aspects of the Gamba Grass Weed Management Plan that we would like to see changed are:

- Section 4.1, "General duties for all land owners and occupiers", states that fire "can be useful
  for managing gamba grass fuel loads and minimising seed production" (p.11), however
  anecdotal evidence continues to emerge that burning seeded gamba spreads the seeds for
  many kilometres into clean areas. A warning to this effect should be included in the plan,
  with a recommendation that gamba be burnt prior to seeding.
- "Table 8. Goal 2 Contain and control gamba grass by actively managing infestations across the Class B zone and preventing spread into new areas" (p.17), states this is to be done by "Land owners, occupiers and all users of land". We would like to see 'including government departments and utility companies' added to this statement, as they are considered to be the main source of infestations by many.
- Table 6 Transport Corridors states, "6.1 For all transport corridors, establish and maintain by chemical, mechanical or physical means, a gamba grass free buffer of 15 m in width on both sides of tracks and roads prior to seeding each year" (p.13) this does not require amending, but needs much more compliance and enforcement, especially along the railway corridor and roadside verges. This 15m buffer must be along both sides of a road and measured from the outer edge of the road. As the buffer must also be on both sides of property boundaries, road verges must also have a 15m gamba free buffer along fence lines something which is rarely if ever done, leaving road verge gamba to hang over property fences and infest neighbouring land. Enforcement is crucial to reducing fire risk and preventing people from becoming frustrated and disenfranchised by reinfestation from transport corridors. We often hear comments like, 'I keep getting rid of my gamba but the government keeps giving it back', and one lady told us that she's been spraying the same strip along her front boundary for 15 years but it keeps getting reinfested by "government gamba".
- Change the performance measures for the Gamba Action Program to better reflect outcomes. The current performance measure is, "The number of people participating in the Gamba Action Program has increased" (Table 10, 4.a, p.19). The success of the Gamba Action Program's objectives cannot be justified if the number of program participants increases, but the amount of herbicide provided has decreased and become inadequate.
- Create and include a framework and criteria for decision making and action to expand the eradication zone.

Q24. Yes, Gamba Grass Roots has found the Gamba Grass Annual Report to be a very useful resource which we often refer to.

Q25. In the future we would like to see the annual Gamba Grass Snapshot included with the gamba grass requirements leaflet in land owners rates notices. We would also like this to be expanded to include other Councils such as Katherine, Victoria Daly (Pine Creek), Darwin and Palmerston Council's rates notices due to the gamba requiring management in these areas.

Q26. Gamba Grass Roots is involved in many actions related to gamba grass. We distribute information, encourage and suggest improvements and advocate for greater gamba reduction and eradication programs, meet with relevant authorities and politicians, have market stalls, attend forums, conferences and events, and a host of other gamba related actions.

Q27. The main things we are told at stalls that impede people from managing gamba are:

- Lack of time due to work and/or family commitments.
- Lack of herbicide due to financial constraints.
- Health and fitness issues due to injury, illness, or age.
- Constant reinfestation making the exercise of removing gamba seem pointless.
- New to the area and don't know what gamba is or their legal requirements.
- Environmental factors such as wet areas prevent people from accessing gamba infestations.

Q28. There has definitely been a change in attitude towards gamba over the last two years. The number of people who tell us of the work they are doing to remove gamba is rapidly increasing and heartening to hear. More people are concerned by the fire risks of gamba-fuelled fires to their properties, the environment, and our national parks. It is the fear of fire that seems to motivate many to manage their gamba and drives them to call for more to be done on neighbouring land, crown lands, road verges and National Parks. We had quite a few people from Darwin River approach our stall at the Berry Springs market, asking how they can report unmanaged gamba and if the (ir)responsible land managers can be fined for noncompliance to encourage them to reduce their gamba fire risk. We refer these people and complaints to the Weed Management Branch.

Q29. It seems that each time we hear of a gamba success story, a fire impacts the property and the gamba returns with a vengeance.

#### Q30. Any other feedback?

It is important that community members can see how the NT is coordinating with the Federal Government's gamba programs with publicly available frameworks demonstrating how the NT and Commonwealth can reduce more gamba grass.

We also need to see more government agencies being held accountable for their unmanaged gamba as the current situation undermines public confidence that Government is taking gamba infestations seriously, with the uncontrolled gamba on public lands often cited as the main driver of gamba infestations on private properties.

More public facing listening and engagement by the Weed Management Branch should also be prioritised in the review of the plan.

Finally, it is important to highlight that this Plan represents a key driver of the response to gamba grass across the Northern Territory. This plan needs to guide decision-makers, be responsive and

open to public scrutiny and ideas, and it is where we will be able to measure success or otherwise as we seek to reduce gamba grass infestations and support community safety.

Q31. Yes, we agree for our feedback to be included in the 2023 Gamba Grass Annual Report.
