Objective of plan	Key outcomes this quarter
(1a-1c)(3a)(4a)	Class A zone gamba grass follow up and updating eradication register for 2022/23 season, environmental and cultural assets areas for prioritisation sent to Gamba Army and attendance at prioritisation workshop (managing gamba for biodiversity conservation), summary of actions taken in relation to goal 3 and next steps, implementation of gamba communications plan.
(2((2e)(2f)(3a)(4a)(4b)(4c)	BFNT Firebreak enforcement program from July to November addressed high gamba fuel loads during the dry season. This included 26 infringement notices, 26 flammable material warnings and 5 flammable material notices under the <i>Bushfires Management Act</i> . Non-compliance with notices allows BFNT to undertake fuel reduction measures to mitigate gamba fire risk, based on level of threat to key assets (life, environment, infrastructure). Some remedial work proposed prior to 2023 bushfire season. Engaged and promoted the work of the Gamba Fire Unit to various stakeholders, including NT Bushfires Council, Gamba Army workshop, partner Council bodies, school events and articles/newsletters. Input into National Gamba Grass Best Practice Manual with Wild Matters.
